**The London Legacy Development Corporation and the London Thames Gateway
Development Corporation (No. 2) Transfer Scheme 2012**

The Secretary of State, in exercise of the powers conferred by section 200(1) and section 218 (2)(3) and (4) of the Localism Act 2011, having consulted the London Thames Gateway Development Corporation and the Mayor of London, makes this Transfer Scheme.

Interpretation

1. In this Transfer Scheme-

"the Act" means the Localism Act 2012;

"LTGDC" means the London Thames Gateway Development Corporation;

"LLDC" means the London Legacy Development Corporation; and

"LLDC Area" means the Mayoral development area as defined in the London Legacy Development Corporation (Establishment) Order 2012 SI 2012/310.

The transfer date

2. The transfer date is 30th September 2012.

**Transfer of property, rights and liabilities of the London Thames Gateway
Development Corporation**

3. -(1) On the transfer date, the property, rights and liabilities of the LTGDC specified in paragraph (2) are transferred to the LLDC.

(2) The property, rights and liabilities referred to in paragraph (1) are-

- a. The rights and liabilities under the contracts specified in Schedule 1A;
- b. The licence specified in Schedule 1B; and
- c. All the property planning files for those sites within the LLDC Area where LTGDC has been the planning decision maker, which will include decision notices on applications and all other associated documents and files.


Transitional, supplementary and incidental provision

4. Anything done (or having effect as if done) before the transfer date by or in relation to the LTGDC in respect of anything transferred by this scheme, has effect on and after that date as if done by or in relation to the LLDC.

5. Anything which, before the transfer date is in the process of being done by, on behalf of or in relation to the LTGDC in respect of anything transferred by this scheme (including legal proceedings) may be continued on and after that date as if done by or in relation to the LLDC.
 6. Any reference to the LTGDC (or its predecessor) in an instrument or other document in respect of anything transferred has effect on and after the transfer date as a reference to the LLDC.
 7. A certificate issued by the Secretary of State will be conclusive evidence that that property has transferred to the LLDC.

Transfer of posts and employees of the London Thames Gateway Development Corporation

8. On the transfer date, the rights and liabilities under the contracts of employment of the individuals employed by the LTGDC specified in Schedule 1C are transferred to the LLDC.
