Thank you for your request for information, received on 24 January 2012. You asked us the following questions:

- 1. Can you please disclose the Olympic Park Legacy Company's financial documents for financial year 2009/10 as they don't appear on the website with the more recent reports?
- 2. On page three of the bid (received in response to a separate FOI request and attached) placed by HR&A Mr Alschuler refers to "previous work" with the Olympic Park Legacy Company. Could you please detail when this 'work' was carried out, the total cost, and the nature of the work? If in the context of that bid "work" is plural then please consider my request applicable to all work carried out by HR&A prior to the 27 January 2011.

Can you please disclose the Olympic Park Legacy Company's financial documents for financial year 2009/10 as they don't appear on the website with the more recent reports?

Before 1 October 2010 our financial records were maintained by LDA. Obtaining this information, amalgamating it with the information we have from 1 October 2010 and converting this information into the format of the financial documents published on the website as part of the Government's transparency agenda would exceed the appropriate cost limit of £450.

Information for the OPLC financial year 2009/10 is available on our website in a document called "A Year in Review with our Annual Report and Accounts 2009/10".

Could you please detail when this 'work' was carried out, the total cost, and the nature of the work? If in the context of that bid "work" is plural then please consider my request applicable to all work carried out by HR&A prior to the 27 January 2011.

HR&A has undertaken one piece of work for OPLC prior to 27 January 2011.

February/March 2010 – through a competitive tender HR&A were awarded a contract for a Strategic Review of the Park and proposals for its transformation and future, with a limited duration and fixed fee of £50,000. The work took place between April and May 2010. We can confirm that HR&A were paid £50,000 on 27 May 2010.
