Thank you for your request for information, received on 3 February 2012. You asked us the following questions:

I would like to receive any risk assessment and risk review documents that the Olympic Park Legacy Company may hold regarding the Olympic Stadium being used by West Ham United Football Club following the 2012 Olympic Games.

I would also like to receive any documents that may act as risk assessments/ reviews, even if not directly titled as so.

Information Held:

- 1. Stadium specific Risk Registers compiled during the previous process
- 2. Stadium specific Issues Logs compiled during the previous process
- 3. Eversheds State Aid Advice

I am unable to provide information in items 1 - 3 as we consider your request to be exempt under Section 43(2) of the Freedom of Information Act 2000 (would or would be likely to, prejudice the commercial interests of any person – including the public authority holding it). Although the information relates to a historic bid process for the Stadium, as you are of course aware, a new process is now underway. The disclosure of the information would be likely to prejudice the commercial interests of OPLC, GLA, other stakeholders and third party bidders in the new tender process relating to the Stadium because it will reveal information which remains current in relation to OPLC's aims and objectives, evaluation methodology and negotiating position in relation to the process. Such information, if in the possession of potential bidders, could affect the ability of OPLC to achieve the best outcome in the new process and secure the best return for the public purse.

In providing this response we have weighed up the balance in being transparent and accountable in respect of our public functions against the need to run a commercial process that is robust in its confidentiality and fairness. We therefore consider that the effect on the commercial interests of OPLC and the prejudice which is likely to be placed on the running of the new tender process by the disclosure of this information outweighs the public interest in disclosing it. It is our view that the public interest is best served by OPLC and other stakeholders in the process maintaining the strictest levels of confidentiality of all information relating to this and related Stadium processes; an ability

to achieve the maximum return for the public purse and the optimum outcome from the current competition requires OPLC to maintain its bargaining position at this time.

I am unable to provide the information in item 3 as we consider your request to be exempt under Section 42 of the Freedom of Information Act 2000 (legal professional privilege). The legal advice included within the Eversheds advice note remains subject to legal professional privilege and should therefore be withheld under section 42 of the FOIA. It has been established that there is a strong public interest inbuilt into this exemption, due to the need to safeguard openness in communications between client and lawyer in order to ensure access to full and frank legal advice, which is essential to the administration of justice. In addition, there is substantial public interest in maintaining this exemption at this time because much of that advice will remain relevant in the context of the new tender process.

Please find attached the information that we hold relevant to your request. We have redacted sections of these documents where information remains commercially sensitive as we consider that the disclosure of this information is likely to prejudice the current process. We have therefore withheld this information under Section 43(2) of the FOI Act. Further, we do not consider that it would be in the public interest to disclose such information at this time.
