Freedom of Information Act 2000 (the "Act") Requests

We refer to your series of requests for information, details in Appendix A. These requests cover the same or similar subject matter and we have therefore treated them as linked requests for the purposes of the Act. We are refusing to comply with the outstanding requests on the basis of section 14(1) of the Act and section 12 of the Act. We will treat any similar requests from you accordingly.

Section 14(1)

You have in total submitted to us 27 FOI requests for information contained in 10 separate submissions. 24 of these requests have been within the last sixty working days. This is a significantly high volume of requests which are all very similar in nature and most, if not all, of which overlap with at least one other request by you. Not only can these requests be legally interpreted as obsessive and extremely broad in nature but responding to these requests will impose a significant burden in terms of expense and distraction of staff from their day to day duties.

It is unclear what purpose or value these requests have and for the most part are requesting explanations from the Legacy Company, rather than requests for recorded information (which is the purpose of the Act). We are happy to release to you details of our procurement processes and governance rules for the procurement of professional services if this is what you require.

Section 12

We previously refused part of your request 13-11 on the basis that compliance with it would exceed the appropriate costs limit of £450 under section 12 of the Act. Since that date you have submitted a total of 24 further requests for the same or similar information, 9 of which we have complied with but all of which we are entitled to treat as linked requests for the purposes of calculating the total cost of compliance under Section 12 of the Act.

Whilst we have to date dealt with your series of requests in good faith, and with the intention of providing disclosure of the documents you have requested, we have calculated that compliance with your requests in conjunction with your requests which we have already answered would clearly exceed the appropriate costs limit under section 12 of the Act which is currently £450. We have calculated this as follows:

On the above basis we are entitled to refuse all outstanding requests.
