Thank you for your request for information, received on 2 July 2013.

You asked the following questions:

"Could you please inform me the full costs of maintaining the safety and the security of the Olympic Park and the Olympic Stadium since the end of the Paralympic closing ceremony. Could you please break this down into costs to Locog and costs to the LLDC.

Could you inform me if these costs stand outside of the costs of maintaining the Olympic Stadium.

[Plus for Fol 13-011] - Would it be possible to have an update on this FOI request? Could you please give me the relevant figures up to today's date."

I have set out below our response to each one of your questions in the following order:

Would it be possible to have an update on this FOI request [13-011]? Could you please give me the relevant figures up to today's date [2 July 2013].

We received your first request for information on 9 May 2013 and responded to you on 7 June 2013 under **FOI 13-011 (13-011)**.

From mid-December 2012 to 30 June 2013 the cumulative spend is £495,300.

Could you please inform me the full costs of maintaining the safety and the security of the Olympic Park and the Olympic Stadium since the end of the Paralympic closing ceremony. Could you please break this down into costs to Locog and costs to the LLDC.

The London Legacy Development Corporation (Legacy Corporation) does not hold information on London Organising Committee of the Olympic Games and Paralympic Games Ltd's (LOCOG) full costs of maintaining the safety and security of the Olympic Park and the Olympic Stadium since the end of the Paralympic closing ceremony, neither does it hold such information in relation to the Olympic Delivery Authority (ODA). The costs reported below have been incurred by the Legacy Corporation since the handover of the venues and site.

- Stadium: £422,487 to end of June 2013.
- The entire Queen Elizabeth Olympic Park (the Park) and venues (excluding the Stadium): £2,980,200 to end of June 2013.

This figure reflects the complexity of safely securing the Park which covers 560 hectares (equivalent to the size of Hyde Park) and includes the permanent venues, multiple construction sites and the immense health and safety challenges involved in successfully ensuring the safety of a large workforce and a security force of 426 at its peak.

## Could you inform me if these costs stand outside of the costs of maintaining the Olympic Stadium.

Yes. The Stadium costs are for safety and security only and do not include maintenance. The maintenance figure for the Stadium is included in our response to your earlier question, identified in 13-011.
