Thank you for your request for information, received on 13 November 2013. You asked us the following questions and I have set out below our response to each one of your questions following your order:

"I am sending you a request for a copy of the proposal that won London the 2012 games. It would also be very useful to get an idea of the strategy that that was used to secure the games.

If for some reason it is not possible to send this information in an email would it be possible to view it at your offices?

It would also be beneficial if it were possible to speak with someone who was involved in the bid to understand the process that won us the games."

London Legacy Development Corporation response:

Item 1 I am sending you a request for a copy of the proposal that won London the 2012 games. It would also be very useful to get an idea of the strategy that that was used to secure the games.

## If for some reason it is not possible to send this information in an email would it be possible to view it at your offices?

The London Legacy Development Corporation (the Legacy Corporation) can confirm that we do hold this information; however, we have determined that the exemption from disclosure under section 21(1) of Freedom of Information Act is engaged. Section 21(1) provides that information which is reasonably accessible to the applicant is exempt information. It has been brought to our attention by the Greater London Authority (GLA) that an electronic copy of the requested information is available in the public domain (The National Archive).

## Item 2 It would also be beneficial if it were possible to speak with someone who was involved in the bid to understand the process that won us the games.
