Thank you for your request for information, received on 21 January 2014. You asked us the following questions:

"Please advise me as to the costs involved in having the Tour de France pass through the Olympic Park and also how much revenue it is anticipated to generate.

The costs should be itemised and include but not be limited to how much paying the Tour de France race organisers; consultancy and agency fees, admin/course stewards, any maintenance/structural works in preparation works and repair.

The anticipated benefits should also be itemised and quantified."

London Legacy Development Corporation (the Legacy Corporation) have set out below our response to each one of your questions following your order:

Item 1 - Please advise me as to the costs involved in having the Tour de France pass through the Olympic Park and also how much revenue it is anticipated to generate.

Planning is progressing for the Tour de France, which will past through the park on 7 July 2014. The route through the park will use Waterden Road only. The planning will establish any operational costs that may be incurred, including any security considerations. All such costs will be the responsibility of the Event organiser – Amaury Sport Organisation (ASO). ASO is the French events company who deliver the Tour de France. http://www.aso.fr/us/works-with-us.html

For the Legacy Corporation we would expect to benefit from more people being in the park using our food outlets and potentially visiting venues.

Item 2 - The costs should be itemised and include but not be limited to how much paying the Tour de France race organisers; consultancy and agency fees, admin/course stewards, any maintenance/structural works in preparation works and repair.

As outlined above, planning is progressing and all costs identified will be passed to the Event Organiser, ASO who also receive any direct revenues generated by the race.

Item 3 - The anticipated benefits should also be itemised and quantified.

The Tour de France is a major sporting event that will bring exposure to a global television audience of over 2 billion people and the ability to market the Park as a world class visitor destination, locally, nationally and internationally.
