Thank you for your request for information, received on 5 February 2014, via your complaint to the Information Commissioners Office ref: FS50528739. The London Legacy Development Corporation (Legacy Corporation) has investigated the details of your complaint once the ICO contacted us and we can confirm that your original request was not received. In order to prevent a reoccurrence the Legacy Corporation have agreed with you that all future correspondence should be sent and received using two separate email addresses as detailed above in order to ensure receipt.

Within your original Environmental Information Regulation request, you asked us the following questions:

*"1. Please provide documents showing the protected trees on the Olympic Park prior to work being done* 

2. Please provide documents presented under the various planning applications showing which trees were to be retained on the Olympic Park

3. Please provide documents showing which trees have been preserved out of those originally protected or marked for preservation now that the Olympics are over."

The Legacy Corporation can confirm that we hold some of the information you have requested. I have set out below our response to each one of your questions following your order. All of the documents below and any further information in relation to the planning applications can be found by entering the planning application reference into the search field of the Legacy Corporation Planning register: <u>https://planningforms.newham.gov.uk/online-applications/</u>.

Item 1 - Please provide documents showing the protected trees on the Olympic Park prior to work being done.

Details of the protected trees in the original plan for the Olympic Park, as shown in drawing OLY-GLB-ILL-DWG-STW-SPC-IND-001 rev1, were originally approved under the 2007 site wide permissions (ref 07/90011 and 07/90010) Conditions SP.0.27, OD.0.32 and LTD.1.18 required compliance with this drawing as stated below:

"The trees to be retained and existing habitats shown on a plan OLY-GLB-ILL-DWG-STW-SPC-IND-001, Rev 1, or any replacement plan approved by the Local Planning Authority, shall be safeguarded until those areas are transferred to a long term management body, after the Games and Legacy Transformation. No retained tree shall be lopped or felled without the prior approval of the Local Planning Authority." Planning Conditions 2007
