## **INFORMATION REQUEST REFERENCE 14-028**

Dear

Thank you for your request for information, received on 25 July 2014. You asked us to provide the following information under the Freedom of Information Act 2000 (FOIA):

*"1) Digital copies of any and all maps of the Olympic site* produced by or for the London Legacy Development Corporation, which depict the past, present or proposed future configuration(s) of the site in the period following the London 2012 Olympic Games.

2) Digital copies of any and all **aerial or satellite photographs of the Olympic site** either held by, or produced by or for the London Legacy Development Corporation, which depict the past, present or proposed future configuration(s) of the site in the period following the London 2012 Olympic Games."

I can confirm that the information you have requested is held by the London Legacy Development Corporation (the Legacy Corporation).

Since the Olympic and Paralympic Games there has been a wide range of different maps produced by the Legacy Corporation for a variety of different events, including but not limited to, last year's summer events series, for North Park opening, for South Park opening, and by a variety of different sections, including but not limited to, Design, Regeneration, Planning, and Transformation.

Considering the above we have estimated that, for these requests, the cost of compliance responding to this request and identifying all of the maps and aerial and satellite photographs of the Olympic Site, either held by or produced by the Legacy Corporation would exceed acceptable costs as defined by section 12 of the FOIA. These figures are based on the FOIA guidelines of £450, which is calculated on the rate of £25 per hour for 18 hours. Even just using the above examples, which do not represent the complete range of options, there would only be 2 ¼ hours for each area to identify, locate, retrieve and extract the information requested.

As a consequence of the above estimation, we will not be processing this request further and this letter acts as a refusal notice under section 17(1) of the Act.

Please note if you could narrow the scope of your request in some way, we may be able to provide the information because it would cost less than the appropriate limit to do so, for

instance, could you focus the request in some way to make it less broad? Any reformulated request will be treated as a new request.

If you are unhappy with our response to your request and wish to make a complaint or request a review of our decision, you should write to:
