INFORMATION REQUEST REFERENCE 14-036

Thank you for your request for information, received on 16 September 2014. You asked us to provide the following information under the Freedom of Information Act 2000 (FOIA):

“Please provide a timetable and maps showing which parts of the Queen Elizabeth Park will be closed to the public over the next two years (until September 2016), as far as you are currently aware.

This should include all construction work, and all events as currently known. It should clearly show exactly which paths and parts of the park will be closed, when, and for what reason.”

At present, we have only limited plans to close any routes, although there may need to be changes to access routes in the coming years as Queen Elizabeth Olympic Park (the Park) evolves, new facilities are built and also on those occasions when larger events take place.

Where possible we aim to communicate all of this with up to one month’s notice to local residents and we send out a regular newsletter by post with details of events that may cause disruption. This newsletter is also posted on our website and you can find the latest information here: <http://queenelizabetholympicpark.co.uk/our-story/get-involved/forums-and-networks>. Perhaps you could let me know your address so that I can check that the newsletter was indeed sent to your location.

In addition to this, regular residents’ meetings are held each year and we ensure that we share as much information as possible at these meetings.

We do not anticipate any road closures in the Park for the remaining events in 2014.

Events in 2015 that will require some form of road closure, include Ride London on August 2, and road closures may be required for the Rugby World Cup matches in the Stadium on September 23, 24 and October 4, 7 and 30. The dates for other events are not yet confirmed, but will be announced on our website in the coming months, please visit <http://queenelizabetholympicpark.co.uk/whats-on/events>.

The Legacy Corporation are currently aware of the following projects that will affect the Park up to September 2016.

- Stadium (works underway)
- F03 (Eastcross bridge) (works underway)
- Canal Park (works underway)
- Car Park cladding
- Ecology area (already closed)
- East Wick Primary School
- Legatum Sweetwater Primary School
- Legatum Free school
- Developer works to commence in East Wick and/or Sweetwater – programme is to be provided by the developer in 2015
- Here East (works underway)
- River footpath connection from Stratford Waterfront to the Parkland in north of QEOP
- Chobham Manor (works underway)
- The International Quarter Office Blocks and residential developments
- General maintenance, minor works as and when required.

As yet we do not have any details on the level of closures that these construction projects may require, if any.

The Legacy Corporation can confirm that at this time we do not hold the information you have requested. Once the information is available it will be made public. The Legacy Corporation recognises the importance of keeping the public, and especially the surrounding communities, aware of the events and construction work planned for the Park and we always aim provide as much advance notice of any disruption as possible.
