## **INFORMATION REQUEST REFERENCE 14-041**

Thank you for your information request, received on 15 October 2014. You asked us to provide the following information under the Environmental Information Regulations 2004 (EIR):

"I would like to make the following request, which may be an EIR

I found this statement in a document by Tim O'Hare Consultants re the reinstatement of East Marsh
TOHA/12/2596/TO

- 4.0 Imported Soils and Soil Ameliorants
- 4.1 Imported Subsoil

It is proposed to import a new 'subsoil layer' to maintain the new levels and to allow for the installation of land drains without disturbing the existing contaminated soils beneath. It is proposed to import a new 'subsoil layer' to maintain the new levels and to allow for the installation of land drains without disturbing the existing contaminated soils beneath. This will be formed by the use of spoil materials obtained from the Olympic Park, validated by PDT and samples taken on site to ensure its suitability.

I would be grateful if you could provide information with documentation and maps to show where on the Olympic Park this 'spoil material' came from, with the information about its validation by the PDT and the samples taken to show its suitability.

In addition, I am unclear how this material arrived at East Marsh. Presumably it had to be stored somewhere after its extraction from the OP before it could be imported to East Marsh. Where was it stored?"

I have set out below our response to each one of your questions following your order:

1) provide information with documentation and maps to show where on the Olympic Park this 'spoil material' came from, with the information about its validation by the PDT and the samples taken to show its suitability.

The 'spoil material' came from the area used as the Olympic warm up track area to the south of the stadium.

Annex A is a map of the warm up track and the proposed excavation as of January 2012.

Annex B contains details of the materials testing.

2) In addition, I am unclear how this material arrived at East Marsh. Presumably it had to be stored somewhere after its extraction from the OP before it could be imported to East Marsh. Where was it stored?

The material was stored in the area of the warm up track until required at East Marsh.
