**Committee terms of reference**

- 4.1. The Committee noted the report which set out the membership and terms of reference of the Communities Committee agreed by the Board at their 22<sup>nd</sup> May meeting.

**Draft food strategy**

- 4.2. The Committee discussed the report on the food strategy proposed for the Queen Elizabeth Olympic Park. This set out the opportunities for the food and beverage offering across the Park and the potential for revenue to be generated from food and beverage activities. The Committee recommended the food strategy to the Board subject to the changes discussed at the meeting.

- 4.3. Following a positive resolution to exclude members of the press and public, in accordance with part 1, paragraph 3 of schedule 12A of the Local Government Act 1972 (as amended), the Committee noted the exempt supplemental information to the food strategy.

#### **Draft ticketing strategy**

- 4.4. The Committee discussed the report on the ticketing strategy proposed for the Queen Elizabeth Olympic Park. This set out the opportunities for ticketing across the Park and the potential where appropriate for revenue to be generated from ticketing activities. The Committee recommended the food strategy to the Board subject to the changes discussed at the meeting.
- 4.5. Following a positive resolution to exclude members of the press and public, in accordance with part 1, paragraph 3 of schedule 12A of the Local Government Act 1972 (as amended), the Committee noted the exempt supplemental information to the ticketing strategy.
