Thank you for your information request, received on 27 March 2015. You asked us to provide the following information under the Freedom of Information Act 2000 (FOIA):

- 1. Documentation showing the original plans as agreed by the ODA planning committee for the restoration of East Marsh post the Olympics
- 2. Documentation showing the modification of those plans by the ODA, OPLC or the LLDC, as agreed in subsequent planning permissions for the restoration of East Marsh.
- 3. Documentation showing what consideration was given at each stage by the ODA, OPLC or LLDC, in drawing up these plans and making modifications to the land, to East Marsh's common land status.
- 4. Documentation from Hackney Council concerning representations made by the Borough to the ODA, OPLC or LLDC and the respective planning committees regarding the common land status of East Marsh and how this should be taken into account when consideration was being given to the restoration of East Marsh.

I have provided our response below following your order:

Item 1: Documentation showing the original plans as agreed by the ODA planning committee for the restoration of East Marsh post the Olympics

The original planning application covering the temporary use of East Marsh recreation ground as a car park was 10-90257-FULODA. This application along with the accompanying plans and decision notice are available to view online via the planning register – please click on this hyperlink - 10/90257/FULODA

The original Officers report is attached as **Annex A**.

The planning application covering the cycle path and landscape bounding the reinstated football pitches was 09-90410-FUMODA. This application is available to view online via the planning register – please click on this hyperlink - 09-90410-FUMODA.

The Officers report is attached as **Annex B.**

The original full planning permission for the Olympic and Legacy Facilities development granted consent for earthworks in association with the reconfiguration of levels and the laying out to provide playing fields and public open space at East Marsh (planning delivery zone 15). This application is available to view online via the planning register – please click on this hyperlink – <u>07-90010-OUMODA</u>, however the officers report is not currently available online and is too large to email. Please let me know if you would like me send you a copy on CD.

Variations to this original planning application were made in subsequent applications; the one referencing East Marsh is 11-90313-VARODA. Again this application is available to view online via the planning register – please click on this hyperlink - 11-90313-VARODA. The officers report is not currently available online but can be included in the CD and sent to you.

Item 2: Documentation showing the modification of those plans by the ODA, OPLC or the LLDC, as agreed in subsequent planning permissions for the restoration of East Marsh. and

Item 3: Documentation showing what consideration was given at each stage by the ODA, OPLC or LLDC, in drawing up these plans and making modifications to the land, to East Marsh's common land status.

From October 2012, the planning function of the Olympic Delivery Authority (ODA) transferred to the Legacy Corporation, however the ODA's planning area was reduced and where appropriate transferred to the local boroughs. See our website for a map of the Legacy Corporation planning area.

From October 2012, planning authority responsibility for the East Marsh area transferred to the London Borough of Hackney (Hackney Council). All planning applications submitted to Hackney Council in relation to planning applications relating to the East Marsh area should be available on the Hackney Council planning register: http://planning.hackney.gov.uk/Northgate/PlanningExplorer/generalsearch.aspx.

Only the ODA planning function and planning records transferred to the Legacy Corporation. On the closure of the ODA in December 2014, the non-planning authority documentation was transferred to the Department for Culture, Media & Sport.

Item 4: Documentation from Hackney Council concerning representations made by the Borough to the ODA, OPLC or LLDC and the respective planning committees regarding the common land status of East Marsh and how this should be taken into account when consideration was being given to the restoration of East Marsh.

The Officers Report mentioned in Item 1 and attached in **Annex A** notes that there was no response received from LBH in relation to this planning application. After the transfer of planning responsibilities to Hackney Council, representations would be made to Hackney Council as the planning authority.
