The London Legacy Development Corporation (Legacy Corporation) confirms that they hold some of the information you have requested. Our response below follows your order:

Question 1.Park Champions Volunteers.

Question 3: Who was in overall charge of the Park Champions for each of the days?

Customer and Mobility Service – The Legacy Corporation through Our Park Life. Wayfinding – UKA (as event organiser) with support from LS185 (London Stadium 185) Liberty Festival and National Paralympic Day – Liberty (as event organiser)

Question 4: British Athletics Volunteers

How many British Athletics Volunteers were deployed at this event?

The Legacy Corporation does not hold this information. BA has not sent us copies of their signing in sheets for their volunteers.

Question 5: What was the British Athletics Volunteers roles for each of the days?

The Legacy Corporation can confirm that some of the British Athletics volunteers were expected to be deployed for wayfinding roles, however at this time the Legacy Corporation does not hold information on other roles that the British Athletics volunteers were deployed.

Question 6: Who was in overall charge of the British Athletics Volunteers for each of the days?

The Legacy Corporation does not hold this information. We had individual contacts for the events. British Athletics will know who had overall responsibility for the British Athletics Volunteers.

Question 7: Did any Park Champions volunteers receive any gifts in kind, eg. complimentary tickets, food, expenses, etc.

Refreshments were provided and a contribution to travel expenses up to the value of £5. Stadium access was made available either through the provision of a ticket or accreditation (depending on the day).

Question 8: Did any British Athletics Volunteers receive any gifts in kind, eg. complimentary tickets, food, expenses, etc.

The Legacy Corporation understand that the British Athletics volunteers were offered the same as the Park Volunteers, although this would have to be confirmed with British Athletics.

Question 9: How was the recruitment process to become a volunteer at this event advertised and or processed.

Volunteers could register directly with British Athletics or could register their interest via the Park Champion programme. Registrations from Park Champions were then passed to British Athletics for final role allocation and instructions.

Question 10: Who is the data controller for the volunteers for this event.

The Legacy Corporation is the data controller for Park Volunteers and British Athletics is the data controller for British Athletics Volunteers.

Question 11: How many Volunteers that were scheduled to attend on the Friday and the Saturday or Sunday did not turn up for Saturday or Sundays shifts?

Wayfinding – This information is held by British Athletics, as event organiser. The Legacy Corporation do not hold this information.

Customer and Mobility Service – All those expected attended their shift.

National Paralympic Day. The Event organiser, Liberty, have provided the Legacy Corporation with the signing in sheets. 27 volunteers were expected, 10 did not attend.

Question 12: Please provide copies of the welfare risk assessments, carried out, for the Park Champion volunteers.

The risk assessment for the Customer and Mobility Service is in **Annex A**. The Legacy Corporation does not hold the risk assessments for the other roles; these are held by British Athletics and Liberty as the event organisers.
