Thank you for your information request, received on 14 August 2015. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"Specifically, I am requesting information on all contracts, documents, ticket manifests, ticket distribution charts, ticket allotment summaries, sponsorship and marketing agreements for events held at the venue over the last 12 months. This is to include anything relating to:

- Proportion of tickets which were made available to the public, ticket brokers, sponsors, private organisations and public organisations;
- The total number of tickets available for every event and how they were sold and
 / or distributed. This includes any draft distribution sheets and plans that were
 incorporated in fact or by reference into the final distribution sheets;
- Limitations or requirements imposed on the resale of tickets;
- Limitations or requirements imposed on the minimum price of resale tickets, including price floors and ceilings;
- Limitations or requirements imposed on the channels, platforms and websites on which tickets could be resold:
- Limitations or requirements imposed on purchasing tickets, including exclusivity agreements;
- Any contracts for exclusive rights of resale;
- Any documents mentioning requirements that ticket brokers commit to reinvesting money earned from ticket resale back into purchasing future tickets from the team;
- Any contracts guaranteeing ticket brokers tickets, whether that guarantee was conditional or unconditional; and
- Revenue sharing agreements between the venue and third parties.

For the purposes of this letter a "ticket broker" is defined as anyone, individually or as a business, who acquired tickets to an event, by any means, for purposes of resale."

Please accept my apologies for the delay in this response; assistance was required in identifying information relevant to your request and then ascertaining who legally held the information. Following on from that investigation, we can confirm that the Legacy Corporation does not hold information falling within the remit of your request; however we have identified that E20 Stadium LLP (E20) hold information relevant to your request.

E20 is subject to FOIA and they are located within our corporate premises. With this in mind, I propose to transfer your request to E20. If you object to this course of action, please let me know by 8 October 2015, otherwise I will transfer the request to E20 on that day for them to respond.

In accordance with the FOIA this letter acts as a Refusal Notice.

If you are unhappy with our response to your request and wish to make a complaint or request a review of our decision, you should write to:
