Thank you for your information request, received on 13 November 2015, clarified on 17 November and with additional information requested on 20 November 2015. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Environmental Information Regulations 2004 (EIR):

"I am writing to gather information upon the percentage of reused and new materials in the production of hub 67. As well as this a list of all the different materials used in the construction process.

Mainly focusing on the reused elements from the olympics but a list of all the construction materials new and reused would be useful, and any others after that were also sourced from the olympic 'left overs'.

In addition to the information already requested, we also wanted to ask for a list of the materials that were available for the architects to use to construct hub 67.

For example what materials could the architects have potentially used?

Could we have the original project brief for the hub 67 competition?

Also have the LLDC carried out any other projects using olympic waste material."

I can confirm that the Legacy Corporation holds information relevant to your request. We do not hold information on the exact percentage of reused and new materials used in the production of Hub 67.

However LLDC can state that the percentage of materials reused in the construction of Hub 67 was significant, and every opportunity for reuse was explored as part of a consistent project approach in design development and delivery. All of the structure within the cabins was reused, with only small reinforcement needed to create a double height community space. All of the substructure and over cladding required to provide suitable insulation etc. was new. The decorative façade was 100% reuse. Internally, the tender documentation made allowance for some replacement (for example costing allowance for 50% of flooring replacement).

We have included within this response a list of the different materials used in the construction and details of reuse. Also included is the originally brief and list of potential items.
