**INFORMATION REQUEST REFERENCE 15-078**

Thank you for your information request, received on 26 November 2015. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

*"1. I understand a lease has been granted to iCity. Please provide copies or details of this lease.*

*2. Please provide details of the present occupants of the former Media and Broadcasting Centre. Which occupants have now started operations from Here East?*

*3. Which potential or agreed occupants have yet to take up occupation? When is it expected each of these be starting operations?*

*4. How many jobs have been created so far?*

*5. How many jobs are expected to be created if/when further occupants start operations?"*

I can confirm that the Legacy Corporation hold some of the information you have requested. Our response follows your order.

*1. I understand a lease has been granted to iCity. Please provide copies or details of this lease.*

The iCity lease, with some commercially sensitive information redacted is available in the public domain, via the Land Registry. The reference for the land registry search is: EGL533902.

*2. Please provide details of the present occupants of the former Media and Broadcasting Centre. Which occupants have now started operations from Here East?*

The Legacy Corporation do not hold a record of this information at this time. However information on the present occupants can be found on Here East's website:

3. *Which potential or agreed occupants have yet to take up occupation? When is it expected each of these be starting operations?*

The Legacy Corporation do not hold a record of this information.

4. *How many jobs have been created so far?*

Innovation City (London) Ltd (iCITY) has submitted an 'Operational Phase Employment & Skills Strategy' to PPDT. This was uploaded onto the LLDC 'planning register' (planning application ref: 15/00542/106) on 30 October 2015 and can be viewed here:

LLDC does not hold complete information on the jobs created so far. The 'Operational Phase Employment & Skills Strategy' (OPESS) produced by iCITY states that an OPESS monitoring report will be submitted to LLDC PPDT on an annual basis and will start from a time after the OPESS has been approved by the PPDT, this document is 'pending consideration' (as of 30th November).

5. *How many jobs are expected to be created if/when further occupants start operations?"*

Innovation City (London) Ltd (iCITY) has submitted an 'Operational Phase Employment & Skills Strategy' (OPESS) to LLDC Planning Policy and Decisions team (PPDT). This was uploaded onto the LLDC 'planning register' on 30 October 2015. The OPESS notes that there are expected to be 5,300 people working at Here East when fully operational, which is expected to be in 2018. The full document can be accessed on
