**INFORMATION REQUEST REFERENCE 16013**

Thank you for your information request, received on 7 March 2016. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

- “1. All monthly invoices submitted by the London Legacy Development Corporation (LLDC) to E20 Stadium LLP (E20) as per the September 2014 services agreement between LLDC and E20.*
- 2. All invoices submitted to a third party by the LLDC as per the September 2014 services agreement between LLDC and E20.*
- 3. Any and all written correspondence between LLDC and E20 that relates to or concerns the payment of the estate contribution by E20 as contemplated in the December 2013 Stadium Island lease, including but not limited to written notifications and indexes.*
- 4. Any and all written correspondence between LLDC and E20 that relates to or concerns any payment on demand requested by LLDC and contemplated in the December 2013 Stadium Island lease.*
- 5. Any and all written correspondence between LLDC and E20 that relates to or concerns the payment of rent by E20 as contemplated in the December 2013 Stadium Island lease.”*

The Legacy Corporation confirm that they hold the information you have requested and the response follows your order:

- Q1. All monthly invoices submitted by the London Legacy Development Corporation (LLDC) to E20 Stadium LLP (E20) as per the September 2014 services agreement between LLDC and E20.*

The invoices raised by the Legacy Corporation and submitted to E20 are attached in Annex A.

Q2. *All invoices submitted to a third party by the LLDC as per the September 2014 services agreement between LLDC and E20.*

No invoices have been raised by the Legacy Corporation to other parties under the services agreement.

Q3. *Any and all written correspondence between LLDC and E20 that relates to or concerns the payment of the estate contribution by E20 as contemplated in the December 2013 Stadium Island lease, including but not limited to written notifications and indexes.*

E20 have not yet paid the Legacy Corporation an estate charge as it is not payable until the completion of the Stadium pre-concession works. The Legacy Corporation holds no documented correspondence between the Legacy Corporation and E20 in relation to or concerning the payment of the estate contribution by E20.

Q4. *Any and all written correspondence between LLDC and E20 that relates to or concerns any payment on demand requested by LLDC and contemplated in the December 2013 Stadium Island lease.*

The Legacy Corporation holds no documented correspondence between the Legacy Corporation and E20 in relation to or concerning any payment on demand requested by the Legacy Corporation other than the invoices attached in Annex A.

Q5. *Any and all written correspondence between LLDC and E20 that relates to or concerns the payment of rent by E20 as contemplated in the December 2013 Stadium Island lease.*

The Legacy Corporation hold no documented correspondence between the Legacy Corporation and E20 in relation to or concerning the payment of rent by E20. In 2014 E20 paid a lease premium of £500,000 in respect of the lease agreement.
