**INFORMATION REQUEST REFERENCE 16080**

Thank you for your information request, received on 16 August 2016. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

*“Please provide the original requirement document that stipulated that the H14 or H16 vehicular bridge was mandatory.”*

The Legacy Corporation can confirm that it holds information relevant to your request. The requirement for the provision of the H14 and H16 bridges is a planning requirement. The LCS planning permission, (reference 11/90621/OUTODA), has a planning condition (LCS0.194) which states that:

“No more than 400 Residential Units in PDZ 4 shall be Occupied unless and until new Bridge H14 (the location of which is shown coloured light green on the Illustrative Plan of Highways & Bridge Locations) has been constructed and completed in accordance with the details approved by the Local Planning Authority pursuant to Condition LCS0.31 and open for use at all times by the general public as a multi-modal vehicle bridge”.

LCS0.195 states that H14 cannot be demolished until bridge H16 is provided (unless bridge structures are being re-used).

The main 2007 Olympic and Legacy Transformation planning permission (reference 07/90010/OUMODA) also included a planning condition (LTD.30) which stated that:

“Unless otherwise approved in writing by the Local planning Authority the bridges H10, H14 and h16 shown on the approved drawings [as highway bridges] shall be provided before the first occupation of the first building within either of the relevant Development Platforms within Planning Delivery Zones 4 and 5 in accordance with details previously approved by the Local Planning Authority”.
