Thank you for your information request, received on 16 August 2016. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"Please provide details of all governance, planning or awarding boards that are jointly attended by LLDC and any other commercial entity.

Clarified on 30 August as: "An example may have been a recent planning board where Balfour Beatty attended as the Project and Delivery Lead company.

I am keen to understand the relationship of LLDC with the property development communities involved."

The Legacy Corporation have a number of 'governance' boards set up for our development projects at Chobham Manor and Eastwick and Sweetwater. We also have project boards set up for the Culture and Education District, on Stratford Waterfront Project Board and the UCL Project Board.

Annex A: The terms of reference for the Chobham Manor Board.

Annex B: The terms of reference for Eastwick and Sweetwater.

Annex C: The suite of terms of references for the Culture and Education District.

It is the standard practice of the Legacy Corporation to redact personal information unless consent to release the information has been received. The names have been redacted from Annex C as we do not have the consent of the individuals to release them.

Section 40(2) – personal information

(2) Any information to which a request for information relates is also exempt information if— (a) it constitutes personal data which do not fall within subsection (1), and

(b) either the first or the second condition below is satisfied.

The section 40 exemption is absolute and is not subject to the public interest test. In this instance, the relevant condition that applies is section 40(2) whereby the information is defined as personal data within Section 1(1)(a) of the Data Protection Act 1998. As we have not received consent of the named data subjects, release of the requested information at this time would contravene the first data principle under Schedule 2(1) of the Data Protection Act 1998.

If you are unhappy with our response to your request and wish to make a complaint or request a review of our decision, you should write to:
