Thank you for your information request, received on 16 August 2016. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Environmental Information Regulations 2004 (EIR):

"Please provide a list of all planning objections that were presented against the proposed bridge design for H14 and H16.

Please provide a list of all objections that were presented against the planning application for bridge H14 and H16."

<u>With clarification</u>, this request was revised to pre-application correspondence in respect of pending applications as no planning applications have been submitted at the time of the request.

## Reg. 13(1) - Personal data

- 13(1) To the extent that the information requested includes personal data of which the applicant is not the data subject and as respects which either the first or second condition below is satisfied, a public authority shall not disclose the personal data.
- (2) The first condition is—
- (a) in a case where the information falls within any of paragraphs (a) to (d) of the definition of "data" in section 1(1) of the Data Protection Act 1998, that the disclosure of the information to a member of the public otherwise than under these Regulations would contravene— (i) any of the data protection principles;

This Regulation states that a public authority shall not disclose personal data, to the extent that the requested information includes personal data of which the applicant is not the data subject and as respects which the conditions in either Regulation 13(2) or Regulation 13(3) apply. In this instance, the relevant condition that applies is Regulation 13(2)(a)(i), whereby the information is defined as personal data within Section 1(1)(a) of the Data Protection Act 1998. As we have not received consent of the data subjects, release of the requested information at this time would contravene the first data principle under Schedule 2(1).

If you are unhappy with our response to your request and wish to make a complaint or request a review of our decision, you should write to:
