**INFORMATION REQUEST REFERENCE 16101**

Thank you for your information request, received on 22 August 2016. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

*“Please can you provide me with the income and expenditure account for the costs operational running and maintenance costs for the Olympic Stadium for each of the last three financial years. Please provide this information at the most detailed level available on the LLDC's accounting and/or management information system(s).*

*Please can you provide me with the job titles of LLDC staff involved in the operation of the stadium and a headcount and FTE for each job title.*

*By "Olympic Stadium" I mean that venue now leased to West Ham United on match days.”*

Our response follows your order:

Q1. *Please can you provide me with the income and expenditure account for the costs operational running and maintenance costs for the Olympic Stadium for each of the last three financial years. Please provide this information at the most detailed level available on the LLDC's accounting and/or management information system(s).*

The Stadium is owned by E20 Stadium LLP, a joint venture between the London Legacy Development Corporation and Newham Council specifically set up to transform and manage the Stadium. E20 Stadium LLP has managed the Stadium since its incorporation in July 2012. The E20 annual accounts have been registered with Companies House and the Legacy Corporation therefore consider this information falls under section 21 FOIA as this information is reasonably accessible to the requestor by other means.

**FOIA Section 21 - Information accessible to applicant by other means.**

*(1) Information which is reasonably accessible to the applicant otherwise than under section 1 is exempt information.*

*(2) For the purposes of subsection (1)—*

*(a) information may be reasonably accessible to the applicant even though it is accessible only on payment, and*  
*(b) information is to be taken to be reasonably accessible to the applicant if it is information which the public authority or any other person is obliged by or under any enactment to communicate (otherwise than by making the information available for inspection) to members of the public on request, whether free of charge or on payment.*

The Stadium is operated on behalf of E20 Stadium LLP by London Stadium 185 Ltd (LS185), a subsidiary of Vinci Concessions. LS185 is responsible for the operational costs of the Stadium. The Legacy Corporation does not hold detailed accounting or management information in relation to LS185's operational costs for the Stadium.

Q2. *Please can you provide me with the job titles of LLDC staff involved in the operation of the stadium and a headcount and FTE for each job title.*

While support services to E20 Stadium LLP are provided by the Legacy Corporation, no Legacy Corporation staff are involved in the operation of the Stadium.
