## **INFORMATION REQUEST REFERENCE 16105**

Dear

Thank you for your information request, received on 26 August 2016. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"With reference to the Concession Agreement between E20 LLP and West Ham United, please provide me with details of the main revenue and costs to E20 derived from each of West Ham's games at the Olympic/London Stadium during August 2016.

For the avoidance of doubt the figures I wish to obtain are

- revenue paid to E20 from Vinci for each of the games
- variable overhead costs incurred by E20 for each of the games
- in particular, police costs charged to E20 in line with the Concession Agreement for each of the games

And my goal in asking for this information is to establish whether E20 (and therefore the taxpayer) has started to receive net revenue from these games. Therefore any other information which you have available, which will help me reach this goal, will be gratefully received.

The games concerned are:

West Ham vs NK Domzale, 4. August West Ham vs Bournemouth , 21 August West Ham vs Astra Giurgiu 25 August

Please also confirm that all three of these games qualify as inclusions in the Match Quota of 25 matches per season, as defined in the Concession Agreement.

Should you decide to assert that this information cannot be made available for reasons of "commercial confidentiality" then please explain your decision in the context of the Information Tribunal ruling which required you to release the Concession Agreement."

The Legacy Corporation response is below, following your order:

- revenue paid to E20 from Vinci for each of the games

E20 Stadium LLP (E20) does not receive revenue from its operator LS185 (a subsidiary of VINCI) on a match by match basis. As such, E20 has not received any revenue from these matches to date.

- variable overhead costs incurred by E20 for each of the games

E20 does not fund the variable overhead costs on a match by match basis. These are met by LS185, and factored into the net revenues ultimately paid to E20. As such, E20 has not incurred any variable overhead costs from these matches to date.

- in particular, police costs charged to E20 in line with the Concession Agreement for each of the games

E20 does not fund police costs on a match by match basis. Where necessary, these are met by LS185, and factored in to the net commercial revenues ultimately paid to E20. As such, E20 has not incurred any police costs from these matches to date.

Please also confirm that all three of these games qualify as inclusions in the Match Quota of 25 matches per season, as defined in the Concession Agreement.

E20 confirm that the three games listed qualify as inclusions in the Match Quota of 25 matches per season, as defined in the Concession Agreement.
