Thank you for your information request, received on 30 August 2016. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"Could you please describe the nature and scale of the last TUPE exercise carried out in 2012."

The Government's Localism Bill includes, as part of its package of devolutionary measures for London, proposals that allow for the creation of Mayoral Development Corporations. In 2011, the Mayor proposed to re-form the Olympic Park Legacy Company as a Mayoral Development Corporation centred on the Olympic Park, but also incorporating a large part of the surrounding area. The set-up of the Legacy Corporation reflected the fact that the Mayor had identified this area as 'London's single most important regeneration project for the next 25 years', because it is where the opportunity of the 2012 Games meets some of the greatest need in the capital.

The formation of the London Legacy Development Corporation (LLDC) in 2012 meant that:-

- the new corporation had ownership of the Olympic Park land and various other public lands bordering the park area,
- LLDC has a full suite of planning and land assembly powers,
- LLDC was governed initially by the Olympic Park Legacy Company board members,
- LLDC has no fixed life span, but is reviewed at regular intervals.

Due to this, staff transferred (TUPE'd) to the LLDC, the Mayoral Development Corporation (MDC) and affected staff within Olympic Park Legacy Company (OPLC), Olympic Delivery Authority (ODA) and London Thames Gateway Development Corporation (LTDGC).

This involved the TUPE of the following:-

LTGDC	4	Planning and Development team whose work was in scope of the surrounding areas to the Park.
