This CRF seeks to request £107,788 nett (excluding VAT) from Project Contingency for the design of a segregated Neutral Fan Zone (NFZ) area in the lower and upper tier hwich represents an additional requirement of West Ham UFC who should fund this change. Any stewards in the area could also help direct fans to the appropriate area; if necessary low level pedestrian type barriers could be used to demarcate the NFZ (provided by the Concessionnaire/Operator). Within both the upper and lower bowl the NFZ should be identifiable, and separated from adjacent groups using netting over banks of seats. Rails barrier not required. Full height screens and barriers should be avoided in the demarcation of the NFZ to avoid creating an intimidating environment.

1 Summar

CRF 071 was agreed at Change Board 19 for £228,000 excl VAT to carry out the first phase of the permanent catering space electrical supplies. Since then, the Operator (LS185) has confirmed final maximum demands for each space, these loads have been formally communicated to the Tier 1 Contractor and the Contractor has subsequently completed the design exercise for the permanent up-grade works. Due to timescales remaining (prior to the June 2016 Stadium Events), there is a requirement to reinstate temporary generation to various catering spaces in advance of the completion of the permanent work.

This CRF is in relation to the requirement for temporary power (generator) supplies to 11No. LS185 / DNC operated kitchens / kiosks. The basis of the provision of the generators shall be as detailed within the Contractors Design Report. The estimated cost of Part 2 works is £400,000 nett excl VAT. This excludes any delay and disruption costs resulting from the additional works and excludes Part 3 works.

2. Impact of the change on scope

Temporary power (generator) supplies to 11No. LS185 / DNC operated kitchens / kiosks. The basis of the provision of the generators shall be as detailed within the Contractors Design Report reference LC419-STA-MEE-E-REP-500-1034 issued to the Project Manager (via e-mail) on 30 March 2016 (attached). In order to facilitate the temporary supplies, 2No. Generator Farms are to be provided, as follows:

From the Generator Farm Distribution Panel, suitably sized / rated SWA cables shall be run (on existing / new containment as appropriate) to wall mounted MCCB Panels (new) that shall be located within existing Switch-rooms as identified within the Contractors Design Report (in order to facilitate ease of relocation to permanent supplies following the 2016 events). From these new MCCB panels, existing / new cables (as detailed within the Contractors Design Report) are to run to the respective kitchen / kiosk. All previously installed temporary (Crosby Electrical provided) isolators shall be replaced with new units, appropriately sized.

GENERATOR FARM 'B

Generator Farm 'B' shall be located at Lower Ground Floor in the space between the permanent South-East life safety / event continuation sets and the adjacent external bicycle racks. The Generator Farm shall be economically sized (to suite the Maximum Demands provided by LS185 / DNC) and shall be provided as un-limited running synchronised sets complete with automatic control and fuel storage facilities. Fuel storage shall be sized to fully serve a full event without the need for re-fuelling. Generators shall be provided complete with a suitably rated TP&N Distribution Panel (adjacent) together with all necessary cabling from the Generators to the Distribution Panel.

From the Distribution Panel, suitably sized / rated SWA cables shall be run (on existing / new containment as appropriate) to wall mounted MCCB Panels (new) that shall be located within existing Switch-rooms (in order to facilitate ease of relocation to permanent supplies following the 2016 events). From these new MCCB panels, existing / new cables (as detailed within the Contractors Design Report) are to run to the respective kitchen / kiosk. All previously installed temporary (Crosby Electrical provided) isolators shall be replaced with new units, appropriately sized.

Failure to approve this change will result in the Stadium having inadequate power supplies for the Operator's Kiosk spaces in the Stadium and kitchen areas in the West Stand.
