Thank you for your information request, received on 7 April 2017. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Environmental Information Regulations 2004 (EIR):

"I am currently doing a dissertation in assessing the extent to which the London 2012 Games were a window of opportunity to increase climate change measures. Through the development of the LLDC following the Games, I was wondering if you could shed some more information as to what extent the LLDC have been able to control the climate actions of the companies operating on the park."

I can confirm that the Legacy Corporation hold information relevant to your request.

Following on from the London 2012 Games, the Legacy Corporation has built upon the legacy of the "greenest games ever" and continues to implement sustainability throughout the Legacy Corporation's different areas of work.

within the LCS outlines how construction companies will operate whilst constructing the Legacy Corporation developments, with a strong focus on environmental protection.
