Thank you for your information request, received 16 May 2017. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Environmental Regulations Act 2004 (EIR):

"As per the Environmental Regulations Act 2004 and in connection with and H14, H16 bridges, could you please send or point me to all detailed environmental information concerning Air Quality and Traffic and pedestrian flows across the whole of the LCS including projected development traffic flows for bridges H14 and H16, used to establish baseline conditions within the Environmental Statement (ES) and Addendum ES accompanying the LCS OPP (September 2012), together with any other environmental information used to determine the applications in 2017."

I can confirm that the Legacy Corporation holds information relevant to your request.

The effects of the Legacy Communities Scheme (LCS) on air quality, including the impacts of road traffic were predicted and assessed as part of the Environmental Impact Assessment (EIA) that was reported in the Environmental Statement (ES) and Addendum ES which accompanied the LCS Outline Planning Permission (September 2012). These documents are available on the <u>Planning Register</u>. For ease I have provided direct links to the relevant applications below:
