Thank you for your information request, received on 19 December 2017. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I would like to make the following Freedom of Information request:

I was looking at the map on page 155 of the Local Plan which purports to show the location of the H16 Bridge. However, comparing the location on the map with a map of the site, as in the attached screenshot, shows that the H14 bridge according the Local Plan is not located at Vittoria Wharf, right next to Forman's site, but further north at Stour Place. A further map on page 169 also fails to locate the H16 bridge at Vittoria Wharf next to Forman's site albeit slightly further south.

I would therefore ask the LLDC to provide information as to how the location for which planning permission for the H16 bridge was granted conforms to the requirements of the Local Plan as set out in these site allocation maps."

Please note that the page numbers provided in your request are from the consultation draft of the Local Plan and not the final adopted version, so these have been provided below for reference.

The drawings within the Local Plan that you refer to are Figure 30 (Sub Area 1 Key Connections) on page 157 of the adopted Local Plan (July 2015) and the drawing included with Site Allocation SA1.8 Sweetwater on page 173. These drawings are purely illustrative, are not intended as precise cartographic maps and have not been produced to any particular scale. Their purpose is to show the principle of the connections and should not be taken as relating precisely to specific buildings or development blocks that they illustrate. In the case

of the bridges H14 and H16, the location and design parameters for the bridges had been established prior to the production of the Local Plan through the Legacy Communities Scheme outline planning permission (11/90621/OUTODA) and earlier through the relevant Olympic phase outline planning permissions and it is the principle of this that is reflected in the 2015 Local Plan drawings.
