Dear Sir,

Thank you for your information request, received on 10 January 2018. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"Please could i request an up to date list of all contractors, subcontractors and suppliers that have or will be involved with the planning, funding, designing, procurement, construction, completion, marketing, management, and disposal of approximately 1,500 units of residential accommodation, together with commercial spaces and recreation areas in the areas of East Wick and Sweetwater on the Park. (Olympic Legacy - Areas 2 & 3, Queen Elizabeth Olympic Park, Central London, London)"

The Legacy Corporation does not hold the information you have requested. There is no business requirement for the Legacy Corporation to hold a list of all contractors, subcontractors and suppliers involved with all the functions you have requested for the areas of East Wick and Sweetwater.
