Thank you for your information request, received on 5 March 2018. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

Under the Freedom of Information Act (2000) I would like to know the following:

- 1. The cost of maintaining the Olympic Park over the last five years
- 2. How much money has been invested into the London Legacy Development Corporation over the last five years
- 3. The revenue generated by the Olympic Park over the last five years

Olympic Park has been clarified to mean the areas covered by the estates and facilities management (EFM) contract.
