Thank you for your information request, received on 8 March 2018. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information Freedom of Information 2000 (FOI):

"I would like to make the following Freedom of Information request:

Please provide the latest projections for housing at Stratford City and expected dates for completion in different locations, e.g. East Village, the International Quarter and any other neighbourhoods.

Please also provide the breakdown of types of housing in terms of the size of units and the quantities of different forms of affordable housing per site within Stratford City.

Please provide details of any specialised housing, i.e. housing designed for disabled or vulnerable people within any of the sites."

I can confirm that the Legacy Corporation holds information relevant to your request. Information on the Legacy Corporation neighbourhoods has already been provided to you under FOI reference: 18-009.

The Legacy Corporation does not own the land at Stratford City and is not responsible for the developments within the area and any information we hold will have been received through the Legacy Corporation's Local Planning Authority (LPA) responsibilities and through the submission of planning applications. The Stratford City site wide housing strategy figures as of February 2017 are attached in **Annex A** and are also publicly available on the planning register on our website: [Planning Register](#), under reference: 17/00044/AOD.

Any other projections for housing within the Stratford City area, that have been provided to us by the developers in relation to a planning application, are publicly available on the planning register on our website: [Planning Register](#).

Within the Planning Register search page, you can search by a variety of criteria including a specific planning reference number, location, time-period or key words that appear within the proposal description field. Depending on the search criteria you have specified a number of planning application records will be returned. Clicking on the applicable reference number will take you to the application details screen which provides a summary of information in relation to that specific planning application and within the tab sections at the bottom of the screen you can find all submitted documentation in relation to that specific application (under the documents tab).

Information regarding housing numbers, types, etc, will be within the various documentation submitted as part of that specific application (e.g. application form, planning statement, etc.)

As the information that we hold relevant to your request is held on our public Planning Register, we are refusing your request under FOIA section 21 as the information is reasonably accessible by other means.

s.21 - Information accessible to applicant by other means.

(1) Information which is reasonably accessible to the applicant otherwise than under section 1 is exempt information.

(2) For the purposes of subsection (1)—

(a) information may be reasonably accessible to the applicant even though it is accessible only on payment, and

(b) information is to be taken to be reasonably accessible to the applicant if it is information which the public authority or any other person is obliged by or under any enactment to communicate (otherwise than by making the information available for inspection) to members of the public on request, whether free of charge or on payment.
