## **INFORMATION REQUEST REFERENCE 18-018**

Dear

Thank you for your information request, received on 12 March 2018. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I wish to request under the Freedom of Information Act 2000 the following information, please supply the total costs of all the contract income paid to road passenger transport operators who have supplied transport to and from the Olympic Park for the calendar years 2015, 2016, 2017 and 2018 for the January and February months, this is to also include any grants paid to any road transport operator, the information can be supplied by email which I would prefer or by hard copy."

I can confirm that the Legacy Corporation holds information relevant to your request. The total costs for 2015, 2016, 2017 and 2018 (January and February only) are shown below.

The costs shown for 2017 and 2018 include any related spend incurred via corporate credit cards; however, for 2016, this only includes any related spend incurred via corporate credit cards from October 2016 onwards. The Legacy Corporation's records for credit card expenditure incurred prior to October 2016 are held in archive and in paper format only. The Legacy Corporation has estimated that the resources required to locate, retrieve, identify and extract the credit card information up to October 2016 will exceed the appropriate limit. Any related spend incurred via corporate credit cards prior to October 2016 is not, therefore, included in the response.

Section 12 of the Freedom of Information Act 2000 makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for the Legacy Corporation is set at £450, calculated as 18 hours at the rate of £25 per hour.

In order to provide you with the credit card information before October 2016, we would need to retrieve the hardcopy records, review all of the credit card statements and extract only those costs associated with your request. The Legacy Corporation cannot justify the cost or the use of resources that would be required to include this information within the response.
