Thank you for your email to the Mayor about the planning applications at Hackney Wick for new bridges and connections (Vittoria Wharf). The Mayor's planning team has been asked to respond.

The Mayor's planning powers are strictly defined by the Mayor of London Order (2008), with the Mayor only allowed to comment on strategic planning applications that meet a set of criteria. Further information on the Mayor's planning powers can be found at the following link:

It is the responsibility of local planning authorities to refer strategic applications to the Mayor, and the Mayor is unable to intervene in applications that do not meet this criteria. In this instance, I can confirm that the London Legacy Development Corporation has not referred these applications to the Mayor, as under the Mayor of London Order 2008, he is not required to be consulted on Reserved Matters applications. The original outline planning permission was referred to the previous Mayor in 2011 and authorises the comprehensive, phased, mixed-use redevelopment of the Queen Elizabeth Olympic Park but the approval of details applications do not require authorisation by the Mayor. As such it is not possible to comment further. I would therefore suggest that you continue to liaise with the LLDC.

I object to the planning applications in the subject title and referenced below.
Summary points are highlighted herein, but i also refer you to web links in each section for detailed
objections which represent my views and should be presented on my behalf.

ref: 16/00588/REM - H16

The proposed H16 site is a 25-second cycle ride from nearest crossings to the north and south -
representing little or no public gain while negatively impacting the conservation area.

It would destroy Vittoria Wharf, an Asset of Community Value (2013) and thriving socio-economic
hub, hosting a cluster of CCI's.

Public opinion is resolutely against H16. A recent survey found 549 local were 99% opposed to H16.

- As public servants you should not wish to ignore this.

Mayor of London's partners in the Creative Land Trust initiative have stated their willingness to
purchase the land to enable the community to become the first in the CLT - this would be a
pioneering case.

The application does not address why the condition LCS04 was imposed in the first place. This is a
striking omission.

Talk of the principles/value of further connectivity in principle, does not go far enough.

If the Zonal Masterplan condition is to be waived, it must be replaced with a cogent technical
argument.

In the original 2012 permission (11/90621/OUTODA) the reason given for excluding the bridges was
to ensure that they were only given permission after a master plan provides the necessary analysis
and clarity to confirm that a bridge

in this location made sense and delivered transport benefits that outweighed its destructive impact.

The bridge applications lack the required analysis that a master plan (ie for Sweetwater) would provide.

There would be a material impact if the bridges were built without this condition.

The transport models/assessments show weak justifications for H14, and indicate that traffic can be well-accommodated by nearby roads.

H14 would adversely affect the conservation area, increase traffic, air pollution, and traffic hazards for families and children, while jeopardising the "Carlton Chimney" stack heritage asset and its setting.

Little consideration has been given as to how resultant traffic would egress from Fish Island.

The 'connectivity' justification ignores the fact that the enclave characteristics of Fish Island are its unique feature and the main reason why people locate there.

H14 would contravene related Fish Island & Whitepost Lane Conservation Area Management Guidelines (2015):

"Fish Island and White Post Lane, and its setting, has a distinctive sense of place that is due, in part, to its island character."

"While allowing for improvements to pedestrian and cycle friendly routes in and out of the area, new developments should have regard to this enclave character. "

The existing community is completely against H14 - This has again been ignored.

Fish Island has undergone many material changes since past assessments, particularly regards socio-economic & cultural environments, including the passage of up to 57000 West Ham fans, new communities and registered assets, and multiple sightings of protected species in the area.

Judgement on both the RMAs & NMA can only be robust with a full and up-to-date EIA.

The accompanying EIR does not mention impact on communities.

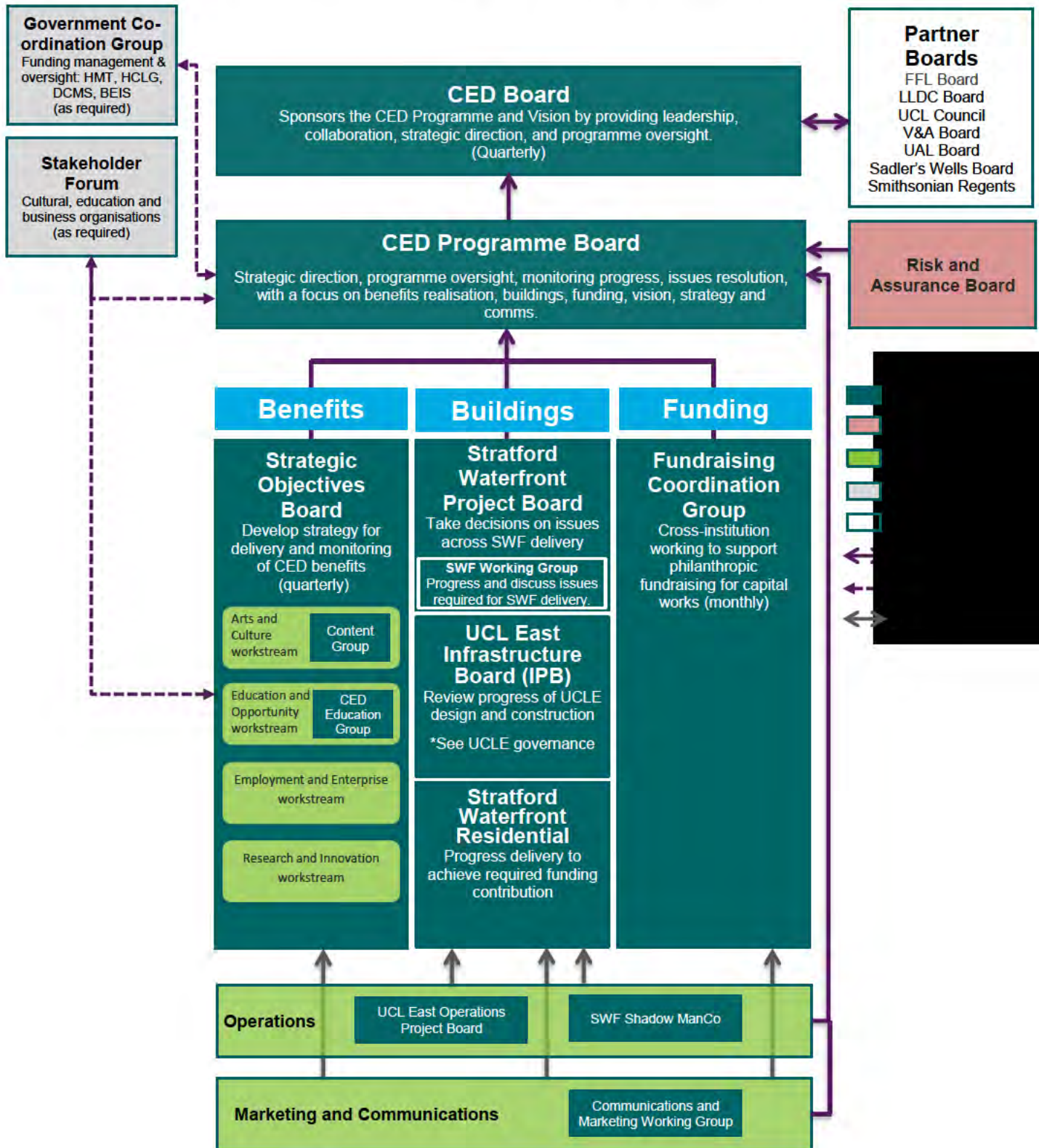
