Thank you for your information request, received on 4 April 2018. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I would like to make the following freedom of information request:

Please provide information regarding the total number of people at present employed in the Olympic Park, with a breakdown of those employed at different facilities, e.g. the Velodrome, the London Stadium, Here East, etc.

Please provide information about the different organisations present at Here East.

I looked on the Infinity East website and it said:

Profile

Infinity Here East is one of the largest and most efficient data centres in Europe. It will be housed in the redeveloped Olympic Broadcast Centre and has 10,300m2 of technical space. It will be fed by multiple power grids, providing exceptional power resilience.

The language used, like 'it will be fed' and 'it will be housed', remains in the future.

Please provide information as to whether the data centre at Infinity Here East is now operating and how many people are employed at Infinity Here East."

I can confirm that the Legacy Corporation holds some information on total workforce, but only in relation to the venues in the Park and the development sites that we are responsible for, as below:

- Chobham Manor – 192 construction workers on site in March 2018
- Estate Facilities Management – 228 people (June 2017)
- Copper Box & London Aquatics Centre (combined GLL workforce in full time & casual roles) – 205 people (April 2017)
- Timber Lodge – 14 people (April 2017)

- Stadium (LS185 permanent staff) – 33 people

This information is not current and the GLL figure is across both LAC and the Copper Box. The Legacy Corporation does not hold information on the employment figures for the venues that are within the responsibility of the Lee Valley Regional Park Authority.

The Legacy Corporation do not hold the information you have requested in relation to whether the Infinity data centre that is based within Here East is operational or how many people it employs.
