Thank you for your information request, received on 14 August 2018. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"Information related [to] current site use

6 years after Olympics, what is the progress in urban infrastructure in the Olympic park, as promised during the legacy plan?

Precisely how much infrastructure was created?

I would like to obtain statistics on number of

Houses

Schools

Hospitals

Bus stops

Libraries

Commercial properties

Etc."

I can confirm that the Legacy Corporation holds information relevant to your request. The Legacy Communities Scheme planning permission was granted outline consent in September 2012 (LPA ref. 11/90621/OUTODA) and includes 643,717sqm development floorspace comprising the following:

542,817sqm of residential providing approximately 5,600 new homes;

20,749sqm of retail, food and drink;

46,139sqm of employment floorspace; and

34,011sqm of community and leisure floorspace.

The section 106 agreement also includes financial contributions for bus infrastructure to deliver 20 new bus stops and the relocation of 2 bus stops.

Development commenced in 2014 and is to be phased over a number of years, with completion expected in 2031.

Chobham Manor, the first neighbourhood with 829 homes, has now completed its first phase and started work on the second. Work is expected to start later this year on the next neighbourhood, East Wick, which includes approximately 900 homes. In addition, the LLDC has delivered two primary schools and one secondary school. The first primary school, Mossbourne Riverside Academy, opened in 2016. The second primary school opened in 2017 as part of the Bobby Moore Academy which also includes a secondary school which is opening on 7 September 2018.
