Thank you for your information request, received on 5 October 2018. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"Olympic Stadium Death 28th June 2015 Under protection of the FOIA 2000, please provide me with the following

- Copy of the HSE and Met Police Report in relation to the Olympic Stadium Death 28th June 2015
- Copy of the latest Lightning Protection Test results for the London Stadium
- Copy of the Completion Certificate for the London Stadium
- Copy of the latest Stadium safety certificate, including the crowd capacity, for the London Stadium?"

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. Our response follows your order:

Q.1. Copy of the HSE and Met Police Report in relation to the Olympic Stadium Death 28th June 2015.

The Legacy Corporation does not hold a copy of the HSE report or Met Police Report in relation to the Olympic Stadium Death on 28 June 2015.

Q.2. Copy of the latest Lightning Protection Test results for the London Stadium.

A copy of the latest Lightning Protection certificate is attached in **Annex A**.

Please note that information has been withheld under FOIA section 40 – personal information.

## Section 40(2) -personal information

- (2) Any information to which a request for information relates is also exempt information if -
- (a) it constitutes personal data which does not fall within subsection (1), and
