Dear Mr Cheyne,

Thank you for your information request, received on 26 October 2018. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I would like to make the following Freedom of Information request:

In April I made a Freedom of Information request, 18-028, to ask how many people were employed at Here East. I was told you do not collect these figures because you are not responsible for the venue or development. However, today I saw an article in the Hackney Gazette claiming Here East is employing 2,500 people - <http://www.hackneygazette.co.uk/news/most-of-the-promised-11-000-jobs-for-2012-olympics-park-site-still-don-t-exist-1-5751367>

In your reply to my request you stated "I can confirm that the Legacy Corporation holds some information on total workforce, but only in relation to the venues in the Park and the development sites that we are responsible for, as below:"

Your response did not include Here East.

- 1. I would be grateful if you could inform me as to why you are now able to provide this figure to the Hackney Gazette journalist when you earlier said you only held information 'in relation to the venues in the Park and the development sites that **we are responsible for**' and were unable to provide it under Freedom of Information rules?*
- 2. Have you now become responsible for Here East?*
- 3. I would be grateful, now that you have made this statement, to have information of exactly where these 2,500 people are employed in the Here East complex and*

who provided this information to you and why, if you can collect it now, you could not collect it from that source before?

The information provided in the Legacy Corporation response reference 18-028 is still accurate.

The Legacy Corporation has not become responsible for Here East.

The employment figure provided to the journalist was obtained by calling Here East before the interview and asking them for the current employment figure and requesting permission from Here East to release the figure in the interview.

The Legacy Corporation does not hold detail on where these people are employed within the Here East complex.
