Five of the six Applicants that submitted SQ responses passed Section A – Applicant Information, which contained pass / fail criteria on Financial Standing, Mandatory Exclusions and Discretionary Exclusions in accordance with the Public Contracts Regulations 2015. Design Build International Ltd failed the turnover threshold and did not have their submission for Section B – Technical and Professional Ability evaluated.
