You said you would like to meet to discuss the [REDACTED] site, but we had a brief discussion over the phone and I said that in principle I support what they are trying to do.

I would actually like to meet soon as I remain keen to progress with the option agreement, so we can continue with our planning application. 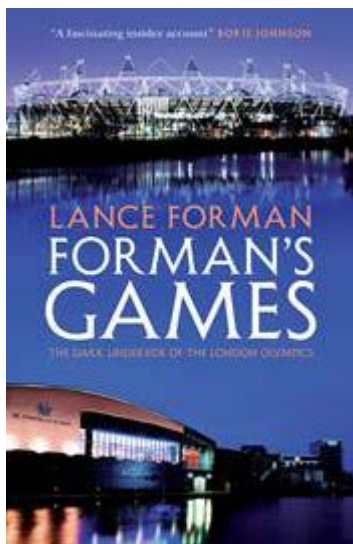

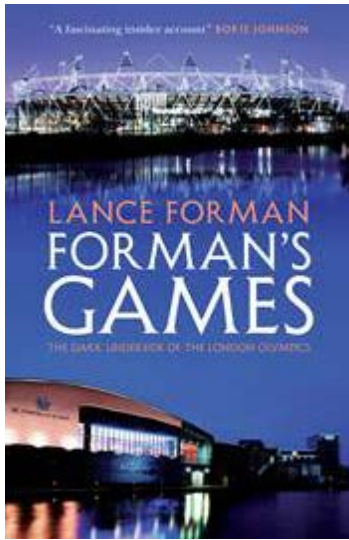
