## **INFORMATION REQUEST REFERENCE 19-024**

Dear ,

Thank you for your information request, received on 9 June 21019. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

Please accept this as a request under the Freedom of Information Act

The briefing provided to Sadiq Khan for a meeting between him, Andy Lustgarten and Jayne McGivern (incorrectly spelled McGiven in the document) on 18th October 2018 at 5.15pm. The proposed agenda includes an "Update on 'Sphere'" at number 2.

Please note that, while a copy of this document is provided on the LLDC website it is heavily redacted. The response letter to this person's FOI partly justifies the redaction on the basis that "The public interest in releasing this information at this time is small, especially with consideration that the pre-application process is still ongoing and a planning application has not yet been submitted." However, the situation has now changed. The planning application has now been submitted and the public interest in this information being released is much higher.

- 725 people have signed <u>an online petition</u> against the proposals so far, with more signatures collected offline.
- As of today, 41 objections have so far been lodged on the planning portal and the Stop MSG Sphere campaign have collected approximately 100 further objections still to be submitted.
- A recent public consultation meeting was well attended by around 50 people and not one person expressed support for the proposals.

Therefore I request that a fuller copy of this document now be provided.

I can confirm that the Legacy Corporation does hold information which falls within the scope of your request therefore please see the attached document.

Please note that information has been redacted under exemption section 43 (2) commercial interests.

## Section 43(2) - Commercial interests.

(2) Information is exempt information if its disclosure under this Act would, or would be likely to, prejudice the commercial interests of any person (including the public authority holding it).

Section 43(2) is a qualified exemption and subject to the prejudice test and the public interest test. Under the prejudice test we have to consider if disclosure of this information would, or would be likely to, prejudice our commercial interests or the commercial interests of a third party.

Consideration is also given to the harm disclosing this information would be likely to cause, combined with other information already in the public domain (mosaic effect) or possibly released at a future date (precedent effect). The public interest test considers and balances the public interest in disclosing this information against the public interest in not disclosing this information and uses this assessment to decide whether there is sufficient justification in withholding this information under this exemption.

Information disclosed under the FOIA is considered to be public information, and while there is a presumption towards disclosure, consideration needs to be given as to who will have access to this information beyond the requestor and the purposes for which they could use the information.

The Legacy Corporation has assessed the impact of releasing the information redacted under the section 43 exemption in order to decide whether disclosure would, or would be likely to, prejudice their commercial interests or those of any third party(ies). They have concluded that prejudice to commercial interests would be caused by disclosure so that the exemption is engaged.

The withheld information relates to the status of the Legacy Corporation's discussions with a third party as part a pre-application process, including details of our negotiation position and the impact of potential issues. Although the planning application has now been submitted, these discussions are still ongoing and remain commercially sensitive. Releasing this information, at this time, would be likely to put the Legacy Corporation at a disadvantage during these sensitive discussions by making public information in relation to their strategy and negotiation position.

There is, of course, the Legacy Corporation's commitment to openness and transparency, as well as the inherent presumption in favour of disclosure of information requested, however, the disclosure of the information currently withheld under section 43(2) and identified as commercially sensitive would be likely to prejudice commercial interests of the Legacy Corporation because it will reveal details which would be likely impact on current and future highly sensitive negotiations and this would in turn would be likely to impact on the Legacy Corporation's ability to get best value for the public purse.

The public interest in releasing this information at this time is small, especially with consideration that the pre-application process is still ongoing and a planning application has not yet been submitted.

It is the view of the Legacy Corporation that, at this time, the public interest in withholding the information outweighs the public interest in disclosing it.
