Thank you for your information request, received on 30 June 2019. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

- Please can you send the lease agreement between the LLDC and DBC given they spent about a year piling up materials on what we understand is the land owned by the LLDC
- 2. <u>Is there also a lease agreement between the LLDC and Network Rail? If so, could you please send that across.</u>
- 3. <u>If there is a lease agreement between the LLDC and Network Rail on Bow Goods Yard i'm assuming there will also be one for the land by Atley Close/Maverton Road.</u>
 We'd appreciate a copy of that also.
- 4. Please can you share a copy of the letter that the CEO of the LLDC sent to his other e-mail address and DB Cargo and also provide copies of their responses

I can confirm that the Legacy Corporation holds information which falls within the scope of your request.

The information relevant to your request is below and our response follows your order:

1. Please can you send the lease agreement between the LLDC and DBC given they spent about a year piling up materials on what we understand is the land owned by the LLDC

I can confirm that the Legacy Corporation does not hold this information as the Legacy Corporation is not party to a lease agreement with DBC. The Legacy Corporation does not own the freehold of the site that is used by DBC to store materials. The Legacy Corporation does own land which is used for access to Network Rail owned land.

2. <u>Is there also a lease agreement between the LLDC and Network Rail? If so, could</u> you please send that across.

I can confirm that the Legacy Corporation does not hold this information. However there is a licence between Network Rail and the Corporation.

Please see the attached licence entitled Annex A.

3. <u>If there is a lease agreement between the LLDC and Network Rail on Bow Goods Yard i'm assuming there will also be one for the land by Atley Close/Maverton Road.</u> We'd appreciate a copy of that also.

I can confirm that the Legacy Corporation does not hold this information as it has no legal interest in this land.

4. Please can you share a copy of the letter that the CEO of the LLDC sent to his other e-mail address and DB Cargo and also provide copies of their responses
