INFORMATION REQUEST REFERENCES 19-041, 42 and 45

Dear

Thank you for your three information requests, received on 8 August 2019 (19-041), 11 August 2019 (19-042) and 21 August (19-045). You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

19-041: whilst traveling I came across some additional thoughts I would like a complete disclosure on, please:

Q1¹. since you bought the company who operate the stadium with public funds, I would now like to know the salary and bonus packages for every employee since the day you acquired the company, after all it is now public funds that will prop it up.

- Q2. Also, I would like a full disclosure on the contract value of the FM company at the stadium.
- Q3. I would imagine you are also paying specialist contractors and consultants, so please disclose all costs incurred or implied, accrued or anticipated that have been in existence since you bought the operating company.
- Q4. In terms of E20 now, please disclose all employees of E20 since 01.01.2015, and their complete remuneration packages, names, titles and positions. This should also include temporary employees, consultants and contract staff of any duration. You should also include any redundancy or leaving employment costs per individual.
- Q5. In terms of LLDC, please disclose the titles, remuneration packages and %'age of time worked since acquiring the stadium operating company in respect of their time spent working on or with the stadium operating company.

- Q6. In respect of LLDC, please declare any and all operating costs since the completion of the London Olympic Games, and a disclosure by financial year-of profit or loss.
- Q7. In terms of all events held or hosted by LLDC, please declare your individual profit or loss on each, individually not cumulative, since 01.01.2013.
- Q8. In terms of any and all consultants utilized by LLDC since, 01.01.2013, please disclose all financial details of money's paid to the individuals or companies, along with a brief explanation of why the services were paid for, with public money.
- Q9. can you please also fully disclose any relationships either personal or professional between any and all of your employees and any and all of your hospitality received, or contracts given, offered or implied. This should be dated back to 01.01.2013.

I have a hospitality ticket for the first home game, so I'm sure I will have more questions following.

- 19-045: Please, I have more information I would like to request.
 - Q32. How was Fr. Lynn Garner chosen for the roll she holds and what academic qualifications does she hold. What's personal or professional relationships did she have with anyone in LLDC OR the Mayors Office at the time of or before her appointment. Please send me a copy of her interview notes.
 - Q33. Please declare membership of any club, committee or other body of any employee of LLDC, E20 and the London Stadium operators in the past 3 years. This should include formal and informal organizations and inclusions by individual employee name. And include any and all current and past employees.
 - Q34. Please declare the use of every box at the London Stadium for every event in the last three years. This should include the name of every attendee and their relationship to every and any employee of LLDC, e20 and LS185.
 - Q35. Please tell me who Mark is who replied to my message.
 - Q36. Please tell me the nominal roll for every Safety Advisory Group meeting for London Stadium for the last three years.
 - Q37. Please tell me the roles and salaries of every current employee of the operating company and their benefits package. Please also provide the same details for the past three years.
 - Q38. I would also request details of anyone at the stadium operating company who has a current or past interest in any company who have or do provide services to the stadium. Please, also include any and all contractors and consultants.
 - Q39. Please declare the names, titles and qualifications of every consultant, contractor or employee of LS185, the stadium operating company, LLDC and E20 for the last three years, provide a copy of their work schedule and detailed information on how they were retained.

I can confirm that the Legacy Corporation holds information relevant to your requests, however, please be advised that FOIA Section 12 allows for the refusal of requests where gathering the information will exceed the "appropriate limit" as set out in the Fees Regulations.

Section 12 - Exemption where cost of compliance exceeds appropriate limit.

(1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

The appropriate limit for the Legacy Corporation is £450, calculated as 18 hours at the rate of £25 per hour, however, only the time spent in;

- a. establishing if the information is held;
- b. locating the information;
- c. retrieving the information; and
- d. extracting the information;

can be taken into consideration when calculating the estimated costs of answering the request.

Further, under FOIA, in circumstances set out in the Fees Regulations, where multiple requests for the same or similar information have been received from the same source within a period of 60 days, the estimated costs involved in responding to each of the requests can be aggregated, including where responses to some of the requests have already been made. If the total estimated cost of dealing with the requests exceeds the appropriate limit then the public authority is not oblided to comply with them.

On 6 August 2019, you contacted the Legacy Corporation with an information request which contained 24 separate requests for information. Our response to this request (FOI 19-039) is attached in Annex A for reference.

When the time required to identify, locate and retrieve the information required to answer your 39 additional requests submitted under FOI 19-041, 19-042 and 19-045 is aggregated with the time already taken to respond to 19-039, the Legacy Corporation will far exceed the appropriate costs limit.

Since the 6 August 2019, you have submitted 63 individual requests for information under FOIA in these four separate requests for information. In the light of the estimated costs of compliance, the Legacy Corporation considers that section 12 FOIA applies and consequently, the Legacy Corporation are not obliged to respond to your requests, and we will not be processing them further.

However, in the interests of providing advice and assistance as required by Section 16 FOIA, we have responded below to some aspects of the requests, where we know the information is already in the public domain, or where a quick answer is possible without reference to recorded information.

Q1. since you bought the company who operate the stadium with public funds, I would now like to know the salary and bonus packages for every employee since the day you acquired the company, after all it is now public funds that will prop it up.

Section 40(2) –personal information

- (2) Any information to which a request for information relates is also exempt information if -
- (a) it constitutes personal data which does not fall within subsection (1), and
- (b) the first, second or third condition below is satisfied.

It is the standard practice of the Legacy Corporation to withhold personal information for those members of staff under Head of Service level unless consent to release the information has been received.

The section 40 exemption is absolute and is not subject to the public interest test. In this instance, the relevant condition that applies is section 40(2) whereby the information is defined as personal data within s.3(2) of the Data Protection Act 2018.
