Thank you for your information request, received on 17 August 2019. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"We are looking at the regeneration of the Olympic Park, and particularly I'm looking at whether the creation of the wetlands area has produced an environmentally sustainable area.

I was hoping to see if you might have any relevant research data about:

- air quality / pollution levels in London or the Olympic Park
- water quality / pollution levels at the Olympic park or relevant nearby areas
- pollution that was caused by the building of the Olympic Park
- biodiversity within the area (plant species, insects etc..)"

I can confirm that the Legacy Corporation holds some information which falls within the scope of your request. The information relevant to your request is below and our response follows your order:

"- air quality / pollution levels in London or the Olympic Park"

The Legacy Corporation does not hold data for air quality/ pollution levels. There are real time air quality monitors on our construction sites, which operate as triggers for alarms if air quality targets (mainly dust related) were exceeded. Any exceedance is managed via our development partner (Mace) to resolve the underlying issue. These issues are reviewed at the Environmental Forum Meetings, but we do not keep records of each air quality alert. "- water quality / pollution levels at the Olympic park or relevant nearby areas"

The Legacy Corporation does not hold data for water quality / pollution levels at Queen Elizabeth Olympic Park. The waterways are managed by the Canals and River Trust <u>https://canalrivertrust.org.uk/</u>.

"- pollution that was caused by the building of the Olympic Park"

The building of the Olympic Park was undertaken by the Olympic Delivery Authority (ODA) not the Legacy Corporation. The Legacy Corporation does not hold data relating to the pollution caused when building the Olympic Park. This information would have been held by the ODA and would have been transferred to the Department of Culture, Media and Sport (DCMS) when the ODA was dissolved in December 2014.
