

## **INFORMATION REQUEST REFERENCE 20-005**

Thank you for your information request, received on 10 January 2020. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I would like to make the following request under the Freedom of Information Act.

Please supply a list of all the external consultants employed by LLDC to provide advice/guidance on the content of planning applications related to the proposed MSG Sphere in Stratford.

For each consultant employed, I would like to know:

The name of the company, or whether it is a private individual; A brief description of the nature of support/services they are or will be providing; Where a contract exists, the start and end date; The budgeted cost; The actual amount paid to date.

I can confirm that the Legacy Corporation holds information relevant to your request.

The following consultants have provided advice and / or guidance to the Legacy Corporation in relation to the proposed MSG Sphere planning application:

Arup	Expertise on environmental assessment and environmental

Jacobs	Expertise on transport and highways matters

The Legacy Corporation have procured the services of Transport Research Laboratory (TRL) through a third party (Jacobs) specifically for the MSG planning application.

With the exception of TRL, the Consultants that have advised on this planning application have been contracted to provide advice to the Legacy Corporation on a number of planning applications and have not been employed exclusively to provide advice or guidance on the MSG Sphere planning application.
