In relation to Bow Goods Yard:

- **Proposed planning application:** Catherine Smyth and I went to the Bobby Moore Academy a couple of weeks ago to update s.40 [REDACTED] and s.40 [REDACTED] on the situation regarding the proposed planning application. I am in regular contact with them. We have a good relationship with them on this issue and they understand our position as an organisation and our role as a planning authority. I just wanted to update you mainly on a developing issue with reputational issues but also to highlight a few things in the cuttings today.

The other issue which is developing is the campaign against the Bow Goods Yard. Bobby Moore Academy has been active on Twitter over the last few days pointing out the large mound of building material, the number of lorries and the impact on air quality. These have been liked by several people including the Mayor of Newham. Meanwhile, in the last few days, a petition has been started to campaign against the plans to come back to planning with new proposals for concrete batching on the site. The link to the petition is below.

It is not brilliantly co-ordinated from an opposition point of view because on one hand there are the complaints on what is happening right now and on the other is a campaign against the proposals which the developer is currently in pre application consultation about. The added issue the petition has put in to the mix is Peter's role with both Network Rail and LLDC.

From a comms point of view we are getting together a very simple one pager on what our role is in this and some background and explanation of what a designated site is. We can then consider placing that somewhere online and directing questions towards it. I wanted to let you know things were bubbling up again in case you are asked when out and about. I am not in EMT next week but it might be worth a discussion.

On top of this the Telford Homes issues continue and we are working with various teams across the LLDC to handle that in the appropriate way as some complaints have come back in since work started again.
