## **INFORMATION REQUEST REFERENCE 20-029**

Thank you for your information request, received on 21 October 2020. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I am interested in the ongoing developments of the Stratford City area and just found the initial report (Stratford Metropolitan Masterplan) from before the Olympic Games in 2012. I would like to request additional and more recent material evaluating the progress on these plans and (if available) insights on the contributions or response of the public.

I would be very grateful if you were able to send any more recent documentations for this specific project."

The Stratford Metropolitan Masterplan was produced for and published by the London Borough of Newham and any specific questions that you have about this document, how it has influenced their subsequent planning policy or related monitoring information should be directed to them.

Since October 2012, the London Legacy Development Corporation (LLDC) has been the Local Planning Authority for the area that includes Stratford City and has had responsibility for producing a Local Plan for its area.
