Thank you for your swift response on this. The photograph I have been sent does seem to indicate a light directed out of the site. Please could you clarify with those on site that any lighting is checked and ensure that it is being used as you have described? Could you get someone on site to send photographs showing the lighting as it is positioned for use? Residents at the properties on Wick Lane have complained about this being a disturbance and I need to be sure the floodlight is not impacting on residential properties.

I will contact you again in January to try and understand further the layout of materials stored on the site and whether they are coming from road and waiting for moving away by rail or coming in by rail and being taken out by road. To ensure that operations are within permitted development rights the important thing is that material is not being brought to the site by road, stored and then removed by road. If that could be confirmed with any detail/evidence, then I think I should not have to question further.
