INFORMATION REQUEST REFERENCE 21-001

Thank you for your information request, received on 29 January 2021. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I would like to request copies of the Here East Annual Monitoring Reports for 2019 and 2020 (if available).

If the reports are not held please provide any information on the reason for this.

The reports are required to be produced each year under the terms of the lease but only the 2018 version appears to have been published by the LLDC."

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. In October 2015, the Legacy Corporation received an application to discharge the planning obligations relating to a written Employment and Skills Strategy for the occupation phase of the Here East development.

The application was approved in January 2016 and is available to view on the Legacy Corporation's planning register under the reference 15/00542/106. We have received an updated Employment and Skills Strategy 2019-2020 (application ref. 20/00125/106), and this was accompanied by the Here East Impact Report which provides a summary of the work that Here East and its tenants have undertaken within the local community. Under the terms of the planning obligation the requirement is that the Developer shall review and if necessary (as agreed by the Tenants Action Group) refresh the Employment and Skills Strategy for each subsequent twelve (12) month period that the Development is Occupied. The submission for 2019-20 is the only update received by the Planning Authority subsequent to the 2016 approved document.

Here East have explained that due to the pandemic, occupation on the site has been much reduced, and it has been agreed with the Legacy Corporation that the survey for the Monitoring Report would be delayed until occupation returns and meaningful data will be received so there will not be a Monitoring Report for 2020.
