**INFORMATION REQUEST REFERENCE 21-008**

Thank you for your information request, received on 16 March 2021. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

*"I am representing Thames Water Utilities Limited in a claim being pursued by a Claimant who tripped whilst walking towards Olympic Village/West Ham Stadium on 30 September 2017. An image below shows the path being taken by the Claimant.*



*I understand the LLDC installed the fence shown at the top of the photograph.*

*I request the following information.*

- 1. Please confirm when the fence was installed by LLDC.*
- 2. Please confirm whether the fence was subject to inspections by LLDC or any other parties?*

3. *Please provide a copy of any inspection records for the period between September 2016 and September 2018.*
4. *Did LLDC carry out any repairs to the fence after the Claimant's accident occurred on 30 September 2017?"*

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. The information relevant to your request is below. Our response follows your order:

Q1. *Please confirm when the fence was installed by LLDC.*

The chestnut pale fencing, as shown in photograph, was installed by LLDC's grounds maintenance contractor – Idverde, during the period 22 December 2016 to 2 January 2017.

Q2. *Please confirm whether the fence was subject to inspections by LLDC or any other parties?*

The fencing was not subject to formal inspections by the Legacy Corporation or other parties on their behalf.

Q3. *Please provide a copy of any inspection records for the period between September 2016 and September 2018. (Please see item 2 response above).*

The fencing was not subject to formal inspections so the Legacy Corporation does not hold any inspection records.

Q4. *Did LLDC carry out any repairs to the fence after the Claimant's accident occurred on 30 September 2017?*

The Legacy Corporation has no record of the fence requiring repair around the time referenced in your request.
