Thank you for your information request, received on 19 March 2021. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"Please supply information regarding the number of people working in permanent jobs at the different locations in the Olympic Park."

The question was clarified as: I was just keeping up with how things are progressing with job creation in general in the Olympic Park, in other words at Here East, the venues, the housing sites, general Park admin/security, such like, which I assume are the categories/locations you would be using. Maybe I should have also referred to categories as well.

I know you have stated in the past the LLDC does not necessarily keep records on all these sites so also to know how, or at which sites, you are at present recording this progress.

I can confirm that the Legacy Corporation holds information which falls within the scope of your request.
